

TERMS & CONDITIONS

ITINERARY: Tour de Forks will make every effort to keep to the advertised route, but reserves the right to make changes at their discretion.

RESERVATIONS AND PAYMENT: To reserve a space on a tour, a reservation deposit is required per person. The balance of the total cost of the trip is required at the office of Tour de Forks no later than 90 days before your departure. If your reservation is made within 90 days of departure, the entire cost of the trip must be paid at the time of reservation. If final payment is not received when due, TDF reserves the right to cancel trip and no refund will be made on deposit.

CANCELLATIONS: A non-refundable per person deposit (see individual tour for amount) is required to reserve a space. Balance is requested 90 days before departure. There is a \$500 penalty charge for cancellations 61-90 days or more prior to departure, 50% of trip price for 31-60 days. Cancellations made 30 days or less prior to departure will result in the loss of monies received. Exceptions to this policy cannot be made for any reason, including personal emergencies. Travel insurance is highly recommended. There is no refund for leaving a program early or arriving late. If, after Tour de Forks has accepted your booking, you wish to change the dates of your reservation or make any other amendments to the booking, an amendment fee of US \$100 per person will be made to cover increased administrative costs.

GENERAL LIABILITY: Tour de Forks (herein referred to as TDF) acts only as an Agent for the hotels, airlines, tour operator and vehicle hire companies, (herein referred to as Suppliers). All coupons, receipts, contracts and tickets issued by TDF are subject to any and all terms, tariff restrictions and services whatsoever offered by the Suppliers. By acceptance of such documents, the traveler agrees to the forgoing and also agrees that neither TDF nor any affiliate companies shall be or become liable or responsible for any loss, injury or damage to person, property or otherwise in connection with any accommodation, transportation or other service or resulting directly or indirectly from beyond TDF's control. TDF does not accept liability for failure on the part of transport companies whose responsibility is confined to their own operations.

TDF, its agents or employees are not liable for the following:

1. Any event beyond their control, included (but not limited to) war, disturbance, fire, flood, unusually severe weather, acts of God, act of Government or other authorities, accident or failure of equipment or industrial actions (whether or not including TDF's or Suppliers employees); nor
2. Any act of commission whatsoever (whether within or outside their control) in relation to any booking, contract, travel, accommodation, excursion or other vacation service (including the carriage of baggage) which results in any direct, indirect or consequential loss, damage, death, injury, delay, liability, additional expenses or inconvenience.

REQUIRED DOCUMENTATION: If you do not hold an American passport, you must have a valid visa to enter Italy. Persons holding other passports must advise their travel consultant at the time of booking and will be advised on special entry requirements necessary.

TRAVEL INSURANCE: TDF accepts no liability or obligation for any death, illness or injury or loss or damage to baggage or personal property caused to or suffered by you in relation to your tour, and any medical condition being taken that may affect your health or ability must be notified to TDF in advance and in writing and must be accompanied by a doctor's certificate as to fitness. You are strongly advised to obtain adequate insurance coverage for all eventualities connected with your tour.

FREQUENT FLYER: TDF is unable to enroll you in any mileage programs. If you are a member of any mileage program, please advise your consultant prior to your departure. TDF is unable supply copies of tickets for past travel retrospective claims.

TRIP CANCELLATION AND INTERRUPTION INSURANCE: It is strongly advised that all travelers purchase trip cancellation and interruption insurance as protection against an emergency which may force you to cancel or leave from a trip while it is in progress. A brochure describing coverage will be sent to you upon receipt of your reservation.

CANCELLATIONS AND ALTERATIONS BY TOUR DE FORKS: TDF reserves the right to cancel your tour for any reason. In this event, TDF shall refund the total monies from each person affected.

SHARE POLICY: Accommodations on all Tour De Forks programs are based on double occupancy. If you are traveling alone and wish to share accommodations, a roommate will be assigned for you whenever possible. When pairing roommates, we will always pair participants of the same sex, and make every effort to accommodate smokers with other smokers. However, if it is necessary to pair a smoker with a non-smoker, overnight accommodations in hotels, ship cabins, etc. will be designated as non-smoking for both participants. If it is not possible to pair you with a roommate, you may be asked to pay a Single Supplement fee for the land portion of the program.

CURRENCY FLUCTUATION: In order to keep our rates as low as possible, we do not build into the price an allowance to cover possible increases from currency fluctuations. Therefore, as currencies do fluctuate constantly around the world, it may be necessary for us to raise the trip cost at any time before departure if there are exceptional cost increases beyond our control.

PARTICIPATION: TDF reserves the right to decline to accept any individual as a trip member for any reason whatsoever.

COMPLAINTS: In the unlikely event that you have reason to complain whilst away, you must immediately notify the Tour de Forks representative. If you remain unsatisfied, you should make your complaint in writing to Tour de Forks within 28 days of the completion of your tour. We regret we cannot accept liability for any complaint about which we are not notified entirely in accordance with this clause.

SERVICES: TDF takes all reasonable care in selecting the people or organizations that provide the services that form a part of your tour. TDF will not be liable for any act, omission, or default in the provision of such services, and nor does any agent have authority to make representations binding on TDF prior to its start, in which case all monies will be refunded.
